Getting started with SmartBlast is simple! Just follow these few basic steps:

1. Fill out the following application. (You must be a SAGE Advantage Member in order to use this SmartBlast service. If you are not a SAGE Advantage Member please call 800.925.7243 for more details and an application.)
2. Either fax in your application with your credit card information, or mail your application to us. It usually takes approximately two business days for us to process your application once payment is received.
3. Once your application has been processed you will receive a welcome email with details on the artwork process.

BLAST SCHEDULING

Blasts can be scheduled as you wish, subject to both schedule availability and, for frequency blasts only, the maximum number of blasts that can be sent based on your selected frequency. For example, if you select two times per month, you may not send more than two blasts per month. If you do not send the maximum number during the time period, the unused blasts can be used in future months, always subject to the frequency maximum.

RESCHEDULING AND CANCELLATION

Blasts may be rescheduled to a future date, subject to schedule availability, at no charge provided that SmartBlast is notified in writing at least four business days prior to the originally scheduled date. No cancellations are permitted and all sales are final.

ART SUBMISSION

Specific art requirements, including deadlines are listed on www.smartblast.com. Art, in the correct format, must be received 5 business days prior to the scheduled date. Art not received in time will incur a late charge and cancellation fees apply if the date is changed less than two business days prior to the schedule. Art, submitted in a different format or art that must be changed, due to format, sizing etc. will incur a fee. Our fees are \$75/hour with a minimum of twenty minutes. All fees will be mutually agreed on unless the charge is \$25 or less in which case it will be billed directly.

PAYMENT TERMS

For anytime blasts, total amount will be invoiced and is due with the order. For frequency blasts, total amount will be billed monthly on a pro rata basis (e.g., a 12 month contract will be billed 1/12 each month) and your credit card will be charged at the beginning of each month unless stated otherwise on your quote.
